Procedure for issue of accreditation certificates and schedules

1 Purpose

1.1 This procedure describes how MAURITAS provides accreditation information to an accredited Conformity Assessment Body (CAB).

2. Scope and Responsibilities

2.1 This procedure sets out the framework under which MAURITAS issues its certificate and schedule of accreditation. It is the responsibility of all MAURITAS staff to adhere to this procedure.

3. References

The following documents contain provisions which, through reference in this text, constitute provisions of the MAURITAS accreditation system. For dated references, subsequent amendments to, or revisions of, any of these publications do not apply. For undated MAURITAS references, the latest edition of the document referred to, applies. 4 Definition

4.1 Accreditation

Accreditation is a third-party attestation related to a CAB conveying formal demonstration of its competence, impartiality and consistent operation in performing specific conformity assessment tasks.

4.2 ILAC MRA Mark

ILAC MRA Mark is registered as a word/device mark and is owned by ILAC.

4.3 IAF MLA Mark

IAF MLA Mark is registered as a word/device mark and is owned by IAF.

4.4 MAURITAS logo-ILAC MRA Mark

The MAURITAS logo-ILAC MRA Mark is the ILAC MRA Mark used in combination with MAURITAS logo for accreditation activities which are covered under the scope for which MAURITAS is signatory to the ILAC MRA. This MAURITAS logo-ILAC MRA Mark is used when issuing accreditation certificates and schedules.

4.5 MAURITAS logo-IAF MLA Mark

The MAURITAS logo-IAF MLA Mark is the IAF MLA Mark used in combination with MAURITAS logo for accreditation activities which are covered under the scope for which MAURITAS is signatory to the IAF MLA. This MAURITAS logo-IAF MLA Mark is used when issuing accreditation certificates and schedules.

4.6 Accredited CAB Combined Mark

The accredited CAB Combined Mark is the ILAC MRA Mark or IAF MLA Mark used in combination with MAURITAS accreditation symbol that the accredited CAB is entitled to use. The Accredited CAB Combined Mark can only be used by the accredited CABs who have signed the relevant contract agreement stating the conditions for use of the Combined Mark.

5 General

5.1 As soon as the Accreditation Committee (AC) approves the granting of accreditation, the Case Officer shall notify the CAB accordingly. The Head of Section shall then allocate a unique accreditation number according to a sequential order by consulting the directory of accredited entities on the MAURITAS website and ensuring that the code given to the newly accredited CAB has not been previously used by an already accredited CAB or a CAB whose accreditation has been withdrawn in the past.

For example:

- For Testing Laboratories, the identification code for the accreditation number shall be T001, T002, T003, etc.
- For Calibration Laboratories, the identification code for the accreditation number shall be C001, C002, C003, etc.
- For Certification Bodies, the identification code for the accreditation number shall be CB001, CB002, CB003, etc.
- For Product Certification Bodies, the identification code for the accreditation number shall be PCB001, PCB002, PCB003, etc.
- For Inspection Bodies, the identification code for the accreditation number shall be IB001, IB002, IB003, etc.

The directory of accredited entities is thereafter updated accordingly on the MAURITAS website.

5.2 A certificate of the standard design shall then be prepared which states the accreditation number, the name of the CAB, any other necessary details of the CAB and the date on which the accreditation became effective.

The effective date of accreditation shall be the date of the accreditation decision by the AC/Director, MAURITAS. The certificate shall be embossed with the MAURITAS logo. The Director, MAURITAS shall sign the certificate and schedule and a copy shall be retained on file.

The relevant templates of MAURITAS Accreditation Certificates are at Annex I to Annex VI in the document.

5.3 At the same time, a schedule of the accreditation scope shall be prepared which, lists the details of accreditation as follows. The relevant templates of MAURITAS Accreditation Schedules are at Annex VII to Annex XVI in the document.

5.4 Laboratories that have been accredited for accreditation schemes for which MAURITAS is signatory to the ILAC MRA as listed below:

- Testing ISO/IEC 17025
- Calibration ISO/IEC 17025

shall be issued a certificate and schedule bearing the MAURITAS logo-ILAC MRA Mark (Refer to Annex I, VII, IX).

5.5 Certification Bodies that have been accredited for the accreditation scheme for which MAURITAS is signatory to the IAF MLA as listed below:

- Management System Certification - ISO/IEC 17021-1 and ISO/IEC 17021-3 with sub-scope QMS ISO 9001
- Management System Certification - ISO/IEC 17021-1 and ISO 22003-1 with sub-scope FSMS ISO 22000
- Management System Certification - ISO/IEC 17021-1 and ISO/IEC 27006-1 with sub-scope ISMS ISO/IEC 27001

shall be issued a certificate and schedule bearing the MAURITAS logo-IAF MLA Mark (Refer to Annex V, XI, XII, XIV).

5.6 MAURITAS shall grant accreditation scopes for QMS in accordance with the sector classification as defined in IAF ID 1. Scoping limitations shall be applied to specific IAF codes if the certification body has not demonstrated competence across the full range of activities within an IAF code during the assessment activity.

5.7 MAURITAS shall grant accreditation scopes for FSMS and HACCP in accordance with the food chain categories and sub-categories as specified in Annex A of ISO 22003-1. If the certification body has demonstrated competence only for specific food chain categories or sub-categories listed in Annex A, the certification body shall be granted a partial accreditation scope.

5.8 MAURITAS shall formally advise the accredited CAB that accreditation has been granted and shall provide an accreditation certificate, accompanied by the schedule of accreditation and two original contract agreements (**F 1.13**) to be signed by both parties. Upon receipt of the signed contract agreement, a soft copy of the relevant accreditation symbol is forwarded to the CAB.

5.9 If the CAB expresses interest for the use of the Combined Mark where applicable, the latter will be required to sign another contract agreement detailing the conditions for the use of the Combined Mark (**F 1.25** for Certification Bodies or **F 1.26** for Laboratories). Upon receipt of the signed contract agreement, a soft copy of the Combined Mark is forwarded to the CAB.

5.10 MAURITAS shall proceed with the issue of amended certificate(s)/schedule(s) in the following cases, where applicable:

- Change in ownership of the CAB
- Change in the name of the CAB
- Change in the address and contact details of the CAB
- Change/Addition/Removal of Technical Signatories
- Extension/Reduction of scope
- Renewal of accreditation
- Change in method
- Change in equipment
- Change in version of standard(s)

5.11 Any technical change on the certificate(s)/schedule(s) shall be approved by the AC/Director of MAURITAS, after consultation with the relevant Technical Advisory Committee (TAC) /Assessor/Technical

Expert, as appropriate, prior to issuing of the amended certificate(s)/schedule(s). Any change that does not warrant any technical input shall be approved by the Director of MAURITAS.

5.12 Upon withdrawal of accreditation, the CAB shall be required to return the accreditation certificate and schedule.

5.13 Upon re-issue of an accreditation certificate/schedule, the CAB shall be required to return the accreditation certificate/schedule, where relevant.

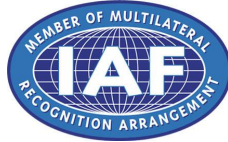
